AFTER SCHOOL SUPERVISION DAY CARE PROGRAM AGREEMENT 2021-2022 SCHOOL YEAR

San Fernando Valley Academy encourages its parents to spend more time with their child at home.

If parents are in need of daycare service, San Fernando Valley Academy offers PAID supervision for both Elementary and High School students, starting fifteen (15) minutes after each class session is over.

The DAILY charges are:

- \$ 8.00 (eight) dollars for the first child
- \$ 6.00 (six) dollars for the second child
- \$ 4.00 (four) dollars for the third child

There is a 20% discount if daycare is paid in advance.

The closing hours for daycare are: Monday through Thursday at 6 p.m. and Fridays at 4:30 p.m.

The parent/guardian agrees not to leave student(s) in Day Care after the closing time in the afternoon. In the case a student is picked up after the daycare operating hours the rate is: **\$1.00 per minute per student, up to a maximum amount of \$60.00. This after hour charge will be paid in cash by the parent/guardian (or person designated) the same day of the service.** The Director may terminate the student's Day Care privileges if the parent/guardian has incurred after hour services for more than one time in a month. For the protection of a student, to the discretion of the Day Care Director, the Los Angeles County Child Protective Services Agency may be notified when a student is left after the daycare hours of operation for consecutive times or for an extended period of time.

*Minimum-day is a short school day in which the student is dismissed at 12:15 pm.

By signing below I acknowledge that I have fully read and understood the Day Care policy. I understand that if I have any questions or concerns regarding daycare, it is my responsibility to discuss it with the daycare director or the business office manager.
